Product Warranty Summary Guide

INTRODUCTION

Thank you for purchasing a Viking Recreational Vehicle. With your new purchase, Viking Recreational Vehicles, LLC provides:

- A one-year base Limited Warranty
- A two-year Limited Structural Warranty

Our warranty has helped propel us to the top of the RV Industry with one of the most comprehensive warranties available today. With few exceptions, our warranty operates as a 'One-Stop' warranty plan backed by a comprehensive network of service centers ready to meet your needs throughout the United States and Canada.

There are also component manufacturers' warranties that extend beyond Viking's warranty coverage. In this booklet you will find a general overview of our Basic and Structural warranties, along with the component warranties available to you.

FOR RECREATIONAL VEHICLES PURCHASED AND DELIVERED IN THE STATE OF CALIFORNIA AND WISCONSIN:

Viking Recreational Vehicle Company, LLC participates in the CAP-RV arbitration program operated by DeMars & Associates. This is a new program that is monitored by the respective states and the appropriate entities of those states certify that the program complies with applicable law.

- (a) In California, the California Department of Consumer Affairs monitors the program. You must use it before claiming any rights conferred by 15 USC Sec. 2301 (Magnuson Moss Warranty Act) or California Civil Code Sec. 1793.22 (b) (Tanner Consumer Protection Act). However, you are not required to use the program if you choose to pursue claims not governed by those laws.
- (b) In Wisconsin, the Wisconsin Division of Motor Vehicles monitors the program. You must use it before claiming any rights conferred by Wis. Stats Sec. 218.0171(7). You may choose to accept or reject the decision. Any waiver by a consumer of his rights under this section is void.

NEW RECREATIONAL VEHICLE BASE LIMITED WARRANTY

Scope

This new Recreational Vehicle Limited 'Warranty' applies only to new vehicles sold by an authorized dealer for one (1) year from the original retail purchase date or the date the vehicle was first put into use ('Warranty Period'). Be sure you read and understand this Limited Warranty. This Limited Warranty applies only to the original owner.

Coverage

This Limited Warranty applies only to materials and components originally built or installed by VIKING RV, LLC. as described below. Provided that you notify VIKING RV, LLC. or one of its authorized servicing dealers of the defect in original materials or workmanship within the Warranty Period, VIKING RV will make any necessary repairs to the 'Recreational Vehicle' and, if applicable, to certain 'Installed Portions' of the product as described below, which may become necessary during the Warranty Period, due to defects in materials or workmanship. We will repair or replace any defective part at no cost to you. If design changes are made, we may substitute parts or components of substantially similar quality, without incurring any obligation to incorporate these changes into any product previously manufactured.

'Recreational Vehicle' (also referred to as 'RV') means all portions of the product which are used or primarily maintained as a temporary mobile dwelling. These 'RV' portions, which may also be described as 'living facilities', include but are not limited to, the plumbing system and fixtures, LP system, appliances, and RV furnace, RV entrance door and exterior compartments and windows.

Defects or damage to interior and exterior surfaces, trim, upholstery, and other appearance items that may occur prior to delivery are usually corrected during the inspection process at the manufacturing facility and the dealership. If you have any concern over any such item when you take delivery of your vehicle, please notify your dealer immediately.

Exclusions

This Limited Warranty does not cover tires, batteries, or any other item or component, which are warranted separately by the respective manufacturers. This Limited Warranty specifically excludes damage caused by improper use, failure to maintain in accordance with the Owner's Manual, improper operation, overloading, abuse, collision, damage due to the environment such as flaking, peeling or discoloration of the exterior or finish, alterations or improper repairs, service call charges, corrosion, cosmetic flaws, or normal deterioration/wear of fabrics and carpeting. This Limited Warranty is void in the event that you use the vehicle other than for its customary purpose, fail to register and use the vehicle in the United States or Canada, and/or use the vehicle for rental, commercial purposes, or continually use as a dwelling for more than thirty (30) days. THIS PRODUCT WAS DESIGNED AND INTENDED TO BE USED FOR RECREATIONAL OR SEASONAL USE ONLY. There is no warranty of any nature made by Viking Recreational Vehicles, LLC beyond that contained in this Limited Warranty. No person has authority to enlarge, amend or modify this Limited Warranty. The dealer is not Viking Recreational Vehicles, LLC's agent but an independent entity. VIKING RV, LLC is not responsible for any undertaking, representation or warranty made by the dealer or any other person different from those expressly set forth in this Warranty.

NOTE: MOLD OR MILDEW CAN OCCUR AS A RESULT OF HIGH HUMIDITY, CONDENSATION OR WATER INTRUSION. PREVENTION OF MOLD AND MILDEW IS A MAINTENANCE ISSUE AND IS THE CUSTOMER'S RESPONSIBILITY. Limitation of Implied Warranties

Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you.

Disclaimer of Consequential and Incidental Damages

THE ORIGINAL PURCHASER OF THE VEHICLE AND ANY PERSON TO WHOM THE VEHICLE IS TRANSFERRED, AND ANY PERSON WHO IS AN INTENDED OR UNINTENDED USER OR BENEFICIARY OF THE VEHICLE, SHALL NOT BE ENTITLED TO RECOVER ANY CONSEQUENTIAL OR INCIDENTAL DAMAGES FROM Viking Recreational Vehicles, LLC. This exclusion shall include, but not be limited to, transporting the vehicle for service, lodging, meals, loss of use of the product, legal expenses, loss or damage to personal property, inconvenience or loss of income. VIKING RECREATIONAL VEHICLES, LLC EXTENDED STRUCTURAL LIMITED WARRANTY

Scope

This Extended Structural Limited Warranty, ('Limited Warranty'), applies only to new vehicles sold by an authorized VIKING RECREATIONAL VEHICLES, LLC dealer for two (2) years from the original retail purchase date or the date the vehicle was first put into use ('Warranty Period'). Be sure you read and understand this Limited Warranty. This Warranty applies only to the original owner.

Coverage

The Extended Structural Limited Warranty applies only to materials and components originally built or installed by VIKING RV as described below. Provided you notify VIKING RV or one of its authorized servicing dealers of the defect in original materials or workmanship within the Warranty Period of two (2) years, VIKING RV will repair the interior and exterior sidewalls, floor structures and ceiling assemblies for all products, and the frame, free of charge for both material and labor, where necessary, due to defects in original material or workmanship. In the event of a design change, we reserve the right to substitute parts or components of substantially similar quality without incurring any obligation to incorporate these changes into any product previously manufactured.

Exclusions

This Limited Warranty specifically excludes damage caused by improper use, failure to maintain in accordance with the Owner's Manual, improper operation, overloading, abuse, collision, damage due to environment such as flaking, peeling or discoloration of the exterior or finish, alterations or improper repairs, service call charges, corrosion, cosmetic flaws, normal deterioration or aging. This Limited Warranty is void in the event that you use the vehicle other than for its customary purpose, fail to register and use the vehicle in the United States or Canada, and/or use the vehicle for rental or commercial purposes. Viking RV products are designed to accommodate a wide variety of uses to meet your travel and RV'ing needs. The design and construction of each unit allows ample room, flexibility and capacity for normal use and cargo. As the owner, you bear the responsibility to properly load your vehicle without exceeding the chassis/ frame weight capabilities. The total weight and distribution of that weight are important safety considerations in the operation of your unit.

For your convenience, Viking RV provides a unit weight information sheet in each recreational vehicle manufactured. Above is a sample of the Unit Weight Information Sheet. Please be responsible in loading your recreational vehicle and do not exceed the net carrying capacity of your vehicle.

We recommend that you have your loaded vehicle weighed prior to leaving on a trip in order to assure that you have not exceeded your maximum carrying capacity. You may check the Yellow Pages for the address and telephone number of the nearest weighing facility (grain elevator, sand and gravel dealer or government weighing station).
